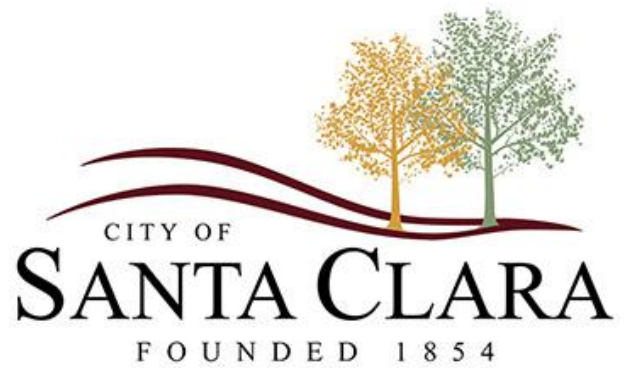

APPROVAL SUBMITTAL CHECKLIST

The Planning Division will only accept complete applications with supporting documents as outlined below. Submitting an application doesn't guarantee that this application will be placed on the next City Council agenda.

The following is required as part of the application form submittal:

- Complete application form
- Non-refundable fee made to Santa Clara City
- Obtain signature of the owner(s) on the application and any authorized representatives
- Engineering drawings

APPROVAL CRITERIA

The planning division will forward a copy of the plat and engineering drawings to the City Engineer and the City Surveyor for their review and comments. As per Utah Code 10-9a-607, the proposed road and dedication plat must meet the municipality standard for roads. Once approved by the City Engineer and City Surveyor, the final dedication plat and financial guarantee for all improvements have to be approved and accepted by the City Council.
